OUCAN is the place for Ohio's urban community action agencies to learn, connect, advocate, and collectively break the cycle of poverty in our communities.

OUCAN CELEBRATES ITS 40TH ANNIVERSARY!

For 40 years, the Ohio Urban Community Action Network (OUCAN) has been a voice for Ohio's urban communities. OUCAN traces its beginnings to 1979, when Community Action Agencies in Akron, Youngstown, and several neighboring cities recognized the need for collaborative efforts to address urban issues. OUCAN, initially known as the Ohio Urban Resources System, was incorporated in 1985 to advocate for Ohio's low-income households in urban communities. Today, Ohio has more large urban centers than any other state, and OUCAN is the nation's oldest urban CAA network.

OUCAN has grown to represent 56% of the state's low-income population. Our network of 10 Community Action Agencies works to reduce poverty, eliminate food insecurity, expand access to housing, and help families earn a livable wage. We serve as a leading resource in enhancing the social and economic stability of families and their communities. Our efforts are further reinforced through community partnerships, collaboration, and advocacy.

It's only through the efforts of committed volunteers, partners, and supporters who share our vision for an equitable future that we have been able to establish a 40-year legacy of impact. And it's only through continued collaboration and cooperation that we will continue to effect change on behalf of Ohio's low-income population well into the future. OUR IMPACT


by the Numbers

OUCAN member agencies are longtime trusted institutions in the communities they serve. As local community-based organizations and designated anti-poverty agencies, Ohio's urban Community Action

Agencies collectively received Community Services Block Grant (CSBG) federal funding of nearly \$19 million dollars and \$1.8 million in additional funding and fiscal awards in 2024.

The 10 OUCAN member agencies made a significant impact on more than 100,000 low-income Ohioans in 2024. Whether through workforce development, childcare, energy and utility assistance, senior programming (including a new Senior Center in Youngstown), or emergency needs during the economic downturn, OUCAN agencies are facilitating the hand up that creates real change in our communities and human investments in Ohioans.





ADVOCACY

Another Big Year for Advocacy

Introduction from OUCAN Advocacy Chair Robert "Bo" Chilton

While programs alone can't solve poverty, OUCAN focuses on policy reform and advocacy. We believe poverty is a policy choice and by prioritizing affordable housing, workforce development tailored to local employers, and universal childcare, we can reduce the number of low-income households living in poverty.

We support direct assisted initiatives such as guaranteed income, Earned Income Tax Credit (EITC), and creating solutions in our local communities to protect low-income families and ensure they receive meaningful support and opportunities.

We are the voice for those who cannot speak for themselves. Keeping our fingers on the pulse of state and federal legislation positions us to monitor policies connected to Ohio's urban communities and work with key elected officials for better outcomes for children, families, and residents.

Ohio Biennial Budget

During Ohio's recent biennial budget process, OUCAN and its members actively engaged in state and federal advocacy efforts to ensure fair and equitable policies to support Ohio's children and families living in poverty.

We partnered with Economic Mobility Alliance to host the first Economic Mobility Advocacy Day. Fifty attendees representing more than 25 agencies gathered at the Statehouse to meet with their state representatives and senators educating them about the impact the "Benefits Cliffs" has on working families. For families like Johonna Hughes, a mother of four small boys, economic programs such as Publicly Funded Child Care (PFCC), the Supplemental Nutrition Assistance Program (SNAP), and Medicaid help bridge the gap when resources are low.

Johonna provided testimony during the Economic Mobility Advocacy Day after sharing about her recent employment barriers. She sought assistance from IMPACT Community Action Agency, the largest urban community action agency in Central Ohio. Even after finding a new job that she enjoyed, once she reported her income to her local Job & Family Services office, her benefits decreased, forcing her back into the situation of Ohio's 1.9 million working households (or 39 percent of Ohio households), who fall under the Asset Limited, Income Constrained, Employed (ALICE) threshold. In plain terms, this means that even with a job, it's difficult to afford the basic cost of living in many Ohio counties (including Franklin County where Johonna lives) causing families to struggle to make ends meet.

National Community Action Foundation Fly-In on Capitol Hill

OUCAN members also traveled to Washington, D.C. and joined members from the Ohio Association of Community Action Agencies (OACAA) and the Corporation for Ohio Appalachian Development (COAD) for the National Community Action Foundation (NCAF) Fly-In Capitol Visits. The current federal funding for Community Action (CA) nationally is \$770 million, and CAs use those funds to advance economic independence and strengthen local communities through key services and programs such as Head Start/Early Head Start, the Community Services Block Grant (CSBG), Weatherization Assistance Program (WAP), and Low-income Home Energy Assistance Program (LIHEAP).

Ohio's poverty rate was 13.2% in 2023 and the state's child poverty rate was 17.5%, according to the latest

report from OACAA (Ohio Capital Journal, 2025). Many of those affected suffer under public policies that create more food deserts, a lack of access to employment, and limited economic opportunities both in the state's rural and urban areas.

OUCAN members joined other CA leaders to meet with Ohio's Congressional delegation and encouraged their support of federal funding distribution to continue to serve Ohioans in need. "By continuing to support CSBG through State and Community Action Agencies, we ensure that hard-working American families have access to the opportunities they need to thrive, while also promoting local economic growth and reducing government dependency," stated NCAF President/CEO David Bradley.

May: Community Action Month

More than ever before, this year's Community Action Month presented new opportunities to tell the CA story, share the successes that embody the CA spirit of hope, and advocate for policies that change people's lives for the better and improve our local communities.

OUCAN agencies celebrated Community Action Month in May through a variety of community-based events. From the seniors at Mahoning Youngstown Community Action Partnership (MYCAP) who formed Seniors Out for Action – or SOFA – to advocate for senior services, to the city-wide Women's Resource Fair at Cincinnati-Hamilton County Community Action Agency, OUCAN members underscored the importance of collective action and partnership to effect change in our communities.


Miami Valley Community Action Partnership (MVCAP) celebrated with an incredible client success story: After months of being unhoused, a Greene County mom and her two kids (ages 9 and 17) found safety and stability through MVCAP's shelter and support services. With the help of caring community partners, she cleared a past housing debt, built a budget, found a job, and worked with MVCAP's team to secure a Housing Choice Voucher.

Today, she and her children are in a home of their own- with rental assistance, energy support through the Percentage of Income Payment Plan (PIPP), and a fresh start.

It's stories like these that embody the hope and dedication of community action and inspire MVCAP and fellow urban community action agencies in everything they do. This is the power of community action!

WORKFORCE DEVELOPMENT

We believe people in low-income communities prefer a hand up to a handout. CAs partner with public and private organizations to connect individuals with training, education, and career support. This year, OUCAN continued to bring awareness to the need for workforce development, and to position members for success.

Self-Sufficiency Simulator


OUCAN CEO Yvonne Cherell joined fellow panelists, Senior Manager of Data and Learning at Interact for Health Colleen Desmond and Vice President of Mission Services at Ohio Valley Goodwill Industries Gladys Ahovi, for the launch of the Women's Fund of Greater Cincinnati Foundation's Self-Sufficiency Simulator. This new interactive tool shows the real cost of living in Ohio cities and towns.

Like OACCA's Self-Sufficiency Calculator, advocates and elected officials can use this new tool to determine the income needed to meet basic needs in each area of the state without public benefits, and considering family composition. The simulator is more precise than the Federal Poverty Level calculation, which does not take into consideration where a person lives, the age of household members, or expenses other than food. "The self-sufficiency data compounded with the simulator tool strengthens

our advocacy efforts and allows us to match data with real human needs," said Cherell. "It illustrates the realities of poverty and emphasizes the need for awareness of how policies can hinder individuals who are working to become self-sufficient."

Self-Sufficiency Simulators are helpful tools to support programs and policies that reduce racial disparities in wages and occupational clustering. All 10 of our member agencies provide workforce development services through innovative, certified career programs. In 2023, OUCAN agencies served 5,555 Ohioans and successfully matched 1,701 skilled workers to higher paying career pathways. Yet, we know that at least 17 participants, or 1% of the people we served, turned down job opportunities or promotions due to the fear of losing their crucial benefits. The Self-Sufficiency Simulator can help drive home this reality for policy makers and leaders.

OUCAN's Women's Leadership Symposium

The OUCAN Women's Leadership Symposium recently took center stage at The Five Party & Event Center in Columbus on May 1, heralding a transformative day dedicated to the celebration and empowerment of women in leadership roles and entrepreneurs. This fifth annual women's symposium was highly anticipated by professionals across various industries and was designed to foster a dynamic environment where women could share, learn, and grow collectively.

The symposium featured an impressive lineup of speakers, panel discussions, and an interactive demonstration by Tracey N. Mason, assistant vice president of outreach & operations at the Federal Reserve Bank of Cleveland, on the Occupational Mobility Explorer.

In September 2024, the Federal Reserve Banks of Cleveland and Philadelphia released an update to the Occupational Mobility Explorer (OME), a tool that allows users to explore potential paths from lower-paying to higher-paying jobs, strengthening the economic performance of the region served by the Cleveland Fed and the nation. With 64 percent of the workforce without higher education degrees, the tool helps to address the top 15-25 requested skills by wage quartile.

With a focus on innovation, resilience, and networking, the event provided attendees with invaluable insights and practical advice to navigate their professional journeys successfully.

Attendees also learned about 2024 Project Noir by Enlightened Solutions – an effort to provide a research-based framework for public, private, governmental, and nonprofit organizations to improve the lived experiences of Black Women.



In 2020, Northeast Ohio ranked dead last as a livable region for Black Women. Enlightened Solutions, co-founded by Chinenye Nkemere and Bethany Studenic, focuses on three key areas: Workplaces, Healthcare, and Education. The 2024 Project Noir report includes information about how individuals and anchor institutions can develop concrete methods for implementing solutions.

Finally, attendees at this year's symposium enjoyed exhibit booths, a networking lunch, panel discussions, and complimentary professional headshots by Purple Star Photography. As women enter leadership positions, a high-quality professional headshot is an important asset to have. A professional headshot helps establish trust with prospective employers, supports your personal brand, and can be a first step toward networking in our digital age. OUCAN was proud to offer this complimentary service to symposium attendees, and we are grateful to Purple Star Photography for doing such wonderful work.

OUCAN CEO Yvonne Cherell, delivered a stirring closing that encapsulated the essence of the symposium's mission. She emphasized the critical need for inclusive leadership and the power of collective action. As Cherell eloquently stated, "Empowerment begins with recognizing the unique strengths and perspectives that women bring to the table. By fostering an environment of support and collaboration, we can drive meaningful change and create a future where women lead with confidence and vision."

SAFE HOUSING



OUCAN has long championed safe housing initiatives that work to ensure Ohioans have options for affordable housing that is safe from toxins, environmental hazards, structural deficiencies, and crime. This year, we are highlighting success stories from our member agencies that exemplify the important progress we are making on the safe housing front.

IMPACT & the Former Columbus YMCA

IMPACT Community Action (IMPACT), together with Woda Cooper Companies and Merchants Capital, announced that it secured \$35.1 million in tax credit equity financing for the historic adaptive reuse of Lofts at 40 Long, an affordable multifamily housing development to be located in the former downtown Columbus YMCA building. The project will convert the historic YMCA building into 121 modern apartments, including one studio, 72 one-bedroom units, 38 two-bedroom units, and 10 three-bedroom units. The units will be restricted to families earning between 30% to 80% area median income (AMI). Construction on Lofts at 40 Long began in August 2025 and is expected to be completed in late 2027.

Step Forward's Ronieta Lee Helps Clients Navigate The Shelter System With Dignity

Step Forward Head Start Parent Ronieta Lee was featured in an article by Signal Cleveland for her work in connecting local families to resources and helping them secure stable housing. Ronieta's story is unique because she once faced homelessness herself, which allows her to come alongside her clients with deep insight into their situations. As noted in the article, Ronieta said, "Having a lived experience being homeless allows me to empathize on a different level. It's not, 'I understand what you're going through.' It is that, 'I inner-stand what you're going through.'" Signal Cleveland added, "The family case manager for LMM, a nonprofit social service organization, helps her clients navigate the shelter system with dignity. She assists them in finding permanent housing while offering moral support and empathy in hopes of positioning these families for lasting success."

MYCAP is Featured in a PBS Series about Displacement After an Explosion in Downtown Youngstown

OUCAN member agency MYCAP was featured in a four-part series on PBS Western Reserve called, "We Are the Aftermath," for its role in assisting residents of International Towers after the May 28th explosion at the Realty Building in Downtown Youngstown.

On that day, a massive explosion, suspected to have been caused by a natural gas leak, collapsed the first floor of the 13-story Realty Building, which was located next door to International Towers. Due to its proximity to the explosion, residents of International Towers were temporarily displaced until their

building could be deemed habitable. The Towers is a 16-story, income-based apartment building that provides affordable housing to 173 residents with disabilities and people 62 and older. PBS Western Reserve chronicled the aftermath of the explosion, including the plight of the Towers residents who found themselves without shelter. MYCAP stepped in and paid for emergency housing for 55 International Towers residents until they could safely return home in late August.

AFFORDABLE CHILDCARE



For parents who need to work, affordable childcare is a necessity, not a luxury. Unfortunately, quality childcare can be cost-prohibitive for many Ohio families, and to make matters worse, market and regulatory forces are combining to make it harder for childcare centers to keep their doors open. That's why OUCAN consistently advocates for policies that will address this barrier to employment and economic sustainability for working families.

Rally for Working Families

On June 17th, OUCAN joined hundreds of advocates from across the state at the Ohio Statehouse for the Rally for Working Families. Together, we called on lawmakers to provide tax relief and make childcare more affordable for working families through a new Ohio Child Tax Credit. We also called for more investments in childcare in the state budget bill. The rally called attention to the needs of Ohio's working families with young children, and OUCAN was proud to stand alongside our partners at this important event.

EDUCATION

OUCAN is committed to providing members with opportunities for high-quality training and education in our ongoing efforts to positively impact our communities with efficiency and effectiveness.

- **Board Governance Training** - Columbus-based Non-Profit Champion and Trainer Libby Villavicencio joined OUCAN for a Board Governance training. As a state designated Training & Technical Assistance network, OUCAN provides training for its members and staff that will directly support community action agencies as they assess compliance areas in Category 5 of the Community Services Block Grant Organizational Standards. More than 60 participants from 24 agencies logged into the virtual session to learn more about board recruitment processes, financial responsibilities, and (when necessary) exit strategies.
- **Results-Oriented Management and Accountability (ROMA) and Community Service Block Grant (CSBG) Organizational Standards Statewide Training** – OUCAN once again held its annual two-day statewide training focusing on ROMA and CSBG organizational standards. This year's event was held on Sept. 25th and 26th at the Main Branch of the Columbus Library. Twenty-five attendees from 13 agencies heard from outstanding presenters Jennifer Atwell, Kerry Austin, Karen Berry, LaSandra James, and Josh Summer. Thanks to the support of our partners – OACAA, the Ohio Legislative Black Caucus Foundation, Advocates for Ohio's Future, NCAF, and the National Community Action Partnership – for making this event a success!

Symposium - The Raymond E. Mason Jr., Leadership Symposium is an annual event at Franklin University designed to enhance leadership in business, nonprofit organizations, government, and educational institutions throughout central Ohio. The symposium acts as a catalyst for organizations and individuals to launch and sustain long-term commitments to developing skilled leadership. This year, OUCAN CEO Yvonne Cherell presented a session titled, "New Pathways in Familiar Places," that explored the evolving roles of women in leadership, business, mentoring, and beyond. The event was held on September 18th, at the Franklin University Leadership Center.

- **Strategic Planning** - OUCAN's Board welcomed Drew Alexander Consulting Founder Tauna Batiste to facilitate the 2026-2029 Strategic Plan and Goals. The two-day retreat also included statewide community partners from OACAA and COAD and an exchange of ideas and best practices among Ohio's community action culture.
